

## ELECTION YEAR 2009

Advance nomination forms should be submitted no later than March 31 of the election year. Nominations will be accepted from the floor if the nominee's qualifications are in compliance with our Constitution and a completed nomination form has been given to-- Director No. 5 or to whomever the President appoints to chair the Nominating Committee---in writing prior to presentation.

Elections are always in April and the positions will be for a two-year term commencing September 1 of the election year.

### **Criteria for Officers**

President, Treasurer, Sergeant-at-Arms

1. A member of the Senate in good standing for five consecutive years preceding nomination;
2. Has served as a delegate to the TNBA Annual Convention two consecutive years preceding nomination;
3. Has served on a Senate Committee or as an Officer or Director for two years.

### **Criteria for Directors**

Director No. 1 - Publicity; public relations, news items; GWBS website

Director No. 3 - All revenue bearing programs, including King & Queen Program

Director No. 5 – GWBS Constitution; Convention delegate information; and hospitality

1. A member of the Senate in good standing;
2. If elected, must serve as a delegate to one TNBA National Convention during the two-year term;
3. Has attended one GWBS open meeting within past year
