TOURNAMENT RULES AND REGULATIONS

1. The 48th Annual Greater Philadelphia Bowling Senate Handicap Doubles Tournament will open Saturday, April 11th @ 11AM and will continue for 3 consecutive weekends, ending on Sunday, April 26th upon completion of the 3:00pm entry.
2. This tournament is open to all bowlers sanctioned by TNBA & USBC and operates under the rules of USBC and TNBA.
3. All contestants WILL USE THEIR HIGHEST SANCTIONED LEAGUE AVERAGE OF THE PREVIOUS SEASON (24-25) PROVIDED THEY BOWLED 21 GAMES OR MORE. All others will use the scratch average of 210. If a bowler has no previous season average, the bowler may use this year's highest average of 21 games or more as of the date of participation in this tournament. Your most recent league standing sheet shall be used as average verification. You must provide the league standing sheet for average verification within 10 days. 10 PIN RULE APPLIES!
4. Failure to use the proper book average shall disqualify the team if the average submitted is lower than actual average, or prize winning will be based on submitted average. Any change in a score must be made to Tournament officials withing 48 hours of bowling.
5. Any bowler without an established league average can enter this tournament with a scratch average of 210 providing they must purchase a membership card before bowling. AT Tournament Site: USBC \$25 and TNBA \$25
6. Standing for the prize list will be based on TOTAL pins for three (3) games bowled on one pair of lanes, plus 100% handicap of 460 for doubles and 100% handicap of 230 for optional singles. Minimum entering average for men is 165 and 140 for women. The prize fund returned is 100%.
7. Tournament Officials reserve the right to accept or reject any entry during the entire tournament. The tournament committee reserves the right to make any decisions for emergencies.
8. FINAL ENTRIES AND RE-ENTRIES WILL CLOSE AT 3:00pm on Sunday, April 26, 2026.
9. Re-entries are allowed. Bowlers may cash with the same partner once but may cash with a change of partners as many times as they make a change. Optional singles only cash once. USBC Rule #315.
10. Should a tie occur for first place, after all teams have completed the final squad on Sunday, April 26, 2026, at 3:00pm, the two teams will split the first and second place prize money.
11. Premature termination of the tournament brought about by any national emergency or any other reasons beyond the control of Tournament Management shall cause the prize schedule to be prorated. It is also agreed that there shall be no liability on behalf of THE GREATER PHILADELPHIA BOWLING SENATE. ALL PRIZES, SCRATCH AND HANDICAP SHALL BE PAID AT THE SAME TIME.
12. Following verification of averages within 10 days, official standings will be posted and payouts will begin.
13. Winner's checks must be cashed no later than 30 days after issue date, the checks will be null, and void and winnings will be lost.
14. ANY PBA, WPBA CARD HOLDER OR UNMARRIED HIGH SCHOOL STUDENT THAT ARE NOT (18)EIGHTEEN ARE NOT ELIGIBLE TO PARTICIPATE IN THIS TOURNAMENT UNLESS PARENTAL CONSENT FORM IS FILED WITH THE TOURNAMENT DIRECTO PER USBC RULE 15.
15. The tournament director has the right to re-rate you if you have ever been re-rated in any previous tournament.
